# b. Financial Report for 2018

The Treasurer spoke to the 2018 Financial Report and presented the Auditor's statement. Our annual deficit continues, as budgeted, and a solution must be found very soon to enable the Society's financial sustainability. Mr Davison related the Council's position that a fund of \$10 - \$30M would be required to sustain the Society's program beyond the next four to seven years, without which it is likely the Society would need to wind down its operations to a volunteer base. The Treasurer, President and CEO responded to queries from members, which were concerned with items of expenditure and the nature of the Inspiring Australia grant conditions.
