#### PRESIDENT'S REPORT

Presidents reporting on the year just gone traditionally observe that the Society has faced challenges yet made progress, and for 2014 there is no exception. The Council has maintained its resolve to ensure the Society remains financially viable and explores new opportunities to fulfil our mission of promoting science to the community. I am grateful to all our members for the support you have shown for these developments, many of which I will comment on in my report.

As usual, our programme of twice-monthly public lectures has underpinned the Society's efforts to promote science, with a wide variety of expert speakers on diverse topics. These lectures have been very well attended, with average audiences numbering in the 60s, so clearly the hard work of the Science Programme committee, chaired by Sandra Rees, is paying dividends. Perhaps the standout, certainly in terms of attendance, was the lecture in September commemorating the 200th anniversary of Matthew Flinders, inspired by the enthusiasm of member Anwyn Martin. The Science Programme committee also co-ordinated the annual Young Scientists Research Awards in September, when the next generation of researchers present their latest discoveries, at the same time as being introduced to the Society. The winners and runners-up are to be congratulated and I hope they will be inspired by the experience to continue their membership of the Society. In a new initiative, the Society held an enjoyable social event for winners of bursaries in the Annual Science Talent Quest run by the Science Teachers Association. We also awarded the second Phillip Law Prize to Dr Madhu Bhaskaran, RMIT and our Research Medal for excellence in medical science to Professor Jane Visvader, who received her award from our Patron, His Excellency the Governor of Victoria, in December. These prestigious awards do much to further the reputation of the Society in the local scientific community.

A highlight of the scientific year was the annual symposium, held this year as a joint initiative between the Society and the Australian Association of Humboldt Fellows, on the topic of Early German Contributions to Victorian science. Planning for this event had a long lead time involving Professor Lynne Selwood and her AAHF colleagues and it's a great credit to everyone that the event was so successful. The Society is especially grateful for the support we received from the German Embassy and also from the Victorian Government, which hosted the closing function at 55 Collins Street. Many of the papers from this symposium will be published in a special issue of the *Proceedings of the Royal Society of Victoria* in 2015.

On the subject of the *Proceedings*, it's fair to say that it has been a challenge for the Society over the past few years. This year in particular we have been without an Editor on Council following Mary Familari's resignation and also had no editorial support, so I'm grateful to Dr Mark Williams, our Honorary Secretary, for putting on another hat in order to assemble the papers from last year's symposium on Victoria's Energy Future for publication. At the time of writing, these were just about to go to the printers, so the 2014 Volume 126 (single issue) will be available early in 2015. As part of our efforts to kick-start the journal and move it into the modern era, the Society has been negotiating an agreement with CSIRO Publishing. A successful outcome will see the journal published in two issues in 2015, online and open access through the CSIRO's website, with a link established on the Society's website. I believe that this arrangement will not only be less costly, but also make the journal more attractive to potential authors.

Members will be aware that we dealt with some administrative challenges through the year. The first was the serious illness that struck James McArthur, our Property and Events Manager, early in the year. After intensive treatment, James made a good recovery and returned to work after several months. By the end of the year he had returned to full health, but at the time of writing he has suffered a reoccurrence and is undergoing more treatment. I'm sure I speak for all members in conveying best wishes to James, Amanda and the children for a full recovery. Doug McCann stepped in to help out during James's illness, allowing us to fulfil our rental commitments. Late in the year our Executive Officer, Dr Jillian de Araugo, tendered her resignation after 18 months with the Society. Jill worked with energy and enthusiasm and did a great deal to improve the way the Society operated, especially the modernisation of the website, with help from Helen Vorrath, an extensive revision of the Society's Rules, and the efficient project management of the car park redevelopment. Jill's resignation placed an additional burden on our loyal and dedicated staff while the Society sought a replacement, and I want to pay tribute to Alex Tsakmakis, Janet Jackson and James for taking on the extra duties. The Society is especially fortunate to have appointed Michael Flattley to the position of Executive Director, and I'm sure all members will extend a warm welcome to Mike and look forward, as I do, to working with him.

I referred above to this year's changes to the Society's Rules, inspired by the need to modernise the operations of Council, by reducing the number of Council members, their maximum term of office and the number of meetings. At the same time, there is a great opportunity and need to involve more members in what have traditionally been Council-dominated functions. These centre round the Council committees involved with the Science Programme, Membership, Publications and Records, and Science Outreach, the last incorporating the Science in my World project. An additional committee, dealing with Policy and Communications, has operated over the past few years in an informal way, but in 2015 will be given more of an official role. I'm grateful for Council members Sandra Rees, David Zerman and Helen Gardiner, who have chaired these committees this year and to those members who have contributed ideas and volunteered their services for committee work. Many of these members also participated in a Members Forum held in August. In particular, we should acknowledge the initiative taken up by Martin Harris, with help from members Helen Gardiner and Doug McCann, to set up the CoderDojo programme of computer education for school-aged children supported by Kieran Nolan at Wooranna Park Primary School. This activity is part of the Science Outreach Programme and complements our involvement with Thornbury Primary School, where Society volunteers led by Rick Tudor are assisting staff with their science teaching. Our annual fundraising event for the Science in my World project was held in May, when Nobel Laureate Professor Brian Schmidt entertained 80 quests at a luncheon at Morgans at 401. Our thanks go once again to Gary Morgan and his staff for their generous assistance to the Society in running this event. Mention should also be made of the Science Policy committee members Dennis O'Neil, Roslyn Gleadow, Peter Baines and Bernie Mace, who have cast their expert eyes over several draft position statements adopted by the Society this year.

Members and visitors who park will now be very familiar with the new car park, which has greatly improved the appearance of the site and its general functionality. Unfortunately, we have not yet been able to hire out any of the six long-term places as intended, but we will continue our efforts early in 2015. The renovation involved extensive discussion with Heritage Victoria, who eventually approved the project and used the opportunity to assess the Society's entire land under the new legislation. I wish to acknowledge the planning advice provided by the Society's long-time heritage advisor, Greg Corbin, as well as Dodge Phoenix's contribution to planting out the site. Another significant change foreshadowed last year was the departure of the Bureau of Meteorology from their monitoring station, which they've leased since 1908. Apart from the loss of a facility that generated significant public interest and valuable scientific data, the Society will forgo rental income from the BoM's move, so we will be looking for ways to recoup that in 2015. Our relationship with our significant tenant, Federation University Australia, remains strong and we greatly value their presence in our building.

The Society's financial situation is sound but, as ever, we maintain perpetual vigilance over expenditure in the light of reduced or static income from rental and membership, a situation that the Honorary Treasurer, Norman Kennedy, will expand on in his report. Our investments, the Science Fund, managed by Equity Trustees, have performed very well over the past year, but we would very much like to add significantly to the capital invested, to provide us with more funds to support scientific activities.

In closing, I would like to express my thanks to our retiring Councillors, who have given valuable service over many years to the Society. Richard Lightfoot, David Churchill, Diane Lightfoot, John Link, Tom Darragh (in the capacity of Honorary Librarian) and Malcolm Carkeek (as Honorary Archivist) have contributed generously with their time and in some cases their donations and I hope they will continue to remain active members of the Society. I am especially grateful for the valuable advice and support the Executive and I have received from retiring Vice-President, Pauline Ladiges, and we all wish her well in her continuing role with the Australian Academy of Science. Finally, on behalf of the Council, I express my thanks to Sandra McColl at Aitken Partners, the Society's legal advisors, for her timely counselling on several significant matters during the year. Let's all hope the Society has much less need for legal advice in 2015!

#### SCIENCE PROGRAMME COMMITTEE

#### 2014 Lecture Series

The twice monthly lecture program ran from 13<sup>th</sup> February to 13<sup>th</sup> November with the RSV Medal presentation concluding the year on 11<sup>th</sup> December. The lectures were very well attended with audiences of between 45 and 110 (average 70) members and the general public. The program included a special lecture celebrating the bicentenary of the death of Matthew Flinders by Dr Gillian Dooley and a lecture marking the International year of Crystallography by Professor Joel Brugger. Excellent lectures covered a wide range of scientific topics including: Optics in Medicine and Biology (A/Professor Paul Stoddart); Curing Plant Blindness and Illiteracy (Professor Tim Entwisle); Picturing Kimberley's Past (Dr June Ross); Medical Bionics: medical solutions for damaged nerves (Professor Rob Shepherd); Coeliac Disease, Gluten Sensitivity and Wheat Intolerance (Dr Jason Tye- Din); Pluto's Moons and the birth of the solar system (Dr Andrew Prentice); Towards a low carbon society (Professor Doug MacFarlane).

In response to members' requests a new initiative in 2015 will be to trial holding lunch time meetings on the fourth Thursday of the month in June, July and August. If this proves to be a popular arrangement we will continue with it in the future.

**Dr Philip Law Postdoctoral Award for Physical Sciences.** The Award was organized by the Committee and won by Dr M. Bhaskaran, RMIT. The award (\$2,000 prize money) attracted 15 excellent entries. We are grateful to the judging panel which included Professors Rachel Webster, Bruce McKellar, Stephen Prawer and A/Professor Roger Hughes. In 2015 the Award will be increased to \$3,000 to enable the recipient to attend an international scientific meeting. A sub-committee to take on the ongoing running of this award is envisaged for the future.

**Young Scientist Research Prizes** were awarded as part of the Society's contribution to Science Week on 25<sup>th</sup> September and the Committee organized the judging. Judges included Professors Richard Harding, Sandra Rees, Pauline Ladiges, Lynne Selwood, Dr Peter Baines, Dr Bill Birch, Mrs Nick Williams and Mr Norman Kennedy. There were 74 entries in three categories: Physical & Earth Sciences, Biomedical & Health Sciences and Biological Sciences (Non-human). As there were only two entries in the Earth Sciences category this year they were combined for the Physical & Earth Sciences prize. The Committee recommended seven young scientists to present their work.

The prizes are supported by the E. D. Gill and Neil W. Archbold bequests and by generous donations from current Society Members; the Society supported the cost of the evening.

The Chair of Science Programs, Professor Sandra Rees, presented \$1,000, a certificate, and membership of the Society for 2014 to the winners:

**Biological Sciences (Non-human) Prize: Kylie Soanes** for her research in "Bridging the Road-gap for Wildlife"

**Biomedical & Health Sciences Prize:** Bevan Main for his work in "Targeting type-1 interferon signalling is neuroprotective in the MPTP mouse model of Parkinson's disease"

Physical & Earth Sciences Prize: Jacqueline Delaney for her work in "Low-cost Sensing for Everyone"

The runners up also received a certificate and prize: Yin Ying Ho, Matthias Koenning, Aliki Rasmiena and Sharmen Rajendran

#### **Archives Report**

After the seven year period during which all the Society's records required for legal purposes are kept in the general office, they are moved to the archives for assessment by the Archivist. The space available at the Society for storing archival material is limited and by their nature the archives grow over time. Therefore the criterion that has been adopted in deciding what is to be kept for posterity and what may be disposed of is "What is the likelihood of this document being of any interest to a future officer and/or researcher?" Council Minutes etc. are obviously a must keep, but invoices for general office consumables are not. In between there is a whole range of topics and individual documents that might be kept or discarded. We cannot keep all documents produced or received by the Society on the off-chance that someone at some time may want to access one. Therefore a rational selection process must prevail. Likely/possible topics that a person may choose to write on are:

- A general history of the Society,
- A history of the Library,
- A history of the buildings and site (including their rental and hire),
- The Membership in general or one member in particular,
- The symposium and lecture series,
- A study of funding of the Society during the twentieth and twenty-first centuries,
- A review of the journal exchange program with other like institutions particularly during the nineteenth century, and
- Awards given by the Society and their recipients.

Material relevant to the above is being collected and appropriately organised.

The last time the Archives was reviewed and rationalised was in the late 1970s to early 1980s. The last two years has seen this brought up to the late 1990s. This work has been challenging because it was found that, not infrequently, documents (sometimes quite important ones) were misfiled, thus requiring that all documents be quickly scanned for a few nuggets in many files of dross.

When I finish my term as Archivist at the next AGM, I expect to have completed my review, culling and organisation of the archival material for the period noted above; and to pass on to the new Archivist a functioning system.

The Chair of the Publications Committee, Mary Familari, resigned from the position of chair of the Publications Committee in mid-2014. Mary made an excellent contribution to the work of the Publications in the RSV in the years leading up to this time. The Transactions from the Energy Symposium held in late 2013 were edited and were ready for distribution early in 2015.

Mark Williams took over as chair of the Publications Committee in mid-2014 and Bill Birch took on the role of Managing Editor. An editorial board was appointed and a contract with CSIRO Publishing was drafted and ready for formalisation early in 2015, with all future proceedings to be published by CSIRO

under open access. Under the agreement with CSIRO there will be two issues of the Proceedings each year. In 2015 the first will be a special issue of the Proceedings following on from the von Humboldt symposium to be published around mid-year. The second will be a normal issue to be published near the end of 2015. A number of manuscripts have been submitted for this issue and it is expected that it will be substantial in content.

With the change to publication through CSIRO it is hoped that the Proceedings will gain wider exposure and that the publication activity of the RSV will gain some momentum, some of which has been lost a little over recent years.

This Committee was created in 2014 to oversee and direct the following activities of the Society:

#### Science in My World

This program was officially launched in July 2014 with an evening workshop on the primary science curriculum led by expert, Ms Helen Trotter. Members and volunteers have since been looking for opportunities to help within their immediate networks and the Coderdojo initiative arose in that context.

Preliminary meetings were held with the Head of Junior School and Head of Science, Junior School at Trinity Grammar to talk about their teachers' needs and our vision for our program. An August meeting with staff at Thornbury Primary School had some very rapid outcomes - some science presentations were arranged for their National Science Week assembly the following week and support to attend the Australian Academy of Science's Primary Connections professional development training over two days was offered to their newly-appointed science coordinator, Ms Lucy Webb, to attend in November. Lucy has since reported back: 'There is a strong focus on developing students' everyday literacy understanding as well as the literacies of science and scientific literacies - an essential skill in today's information loaded society. I highly recommend this training.' A very kind offer was made by the Academy to support Lucy's PD and this has meant we have been able to set aside the funds intended for that for future activities.

RSV Members Rick Tudor and Martin Harris have since spent a day cleaning out and stocktaking Thornbury Primary School's science resources and staff were pleased with the results. Rick has now agreed to act as a resource for Lucy in her work, and we expect further requests for assistance will be met by the resources of the Committee.

#### Coderdojo

With seed funding from Dr Alan Finkel, AO FTSE and with the sustained commitment of Martin Harris and Doug McCann (member) Melbourne's first Coderdojo started on Sunday 7 December 2014 at Wooranna Park Primary School in Dandenong North and is continuing into 2015. Regular attendances have been averaging between 20 to 26. The student ages range from 8 to 16 and they come with their equally enthusiastic parents. Approximately half the students are doing formal coding and simple program writing and others are occupied with various games. Some of these projects are: Oculus Rift, Leap Motion, Drone Technology, Java, HTML5, Python and C++ Coding and Networking Technologies. Future projects include Unity coding and Google Drive API. Some of the funds for the program have contributed to the purchase of some extra equipment for such programs both for the Coderdojo and for the school's use.

Thanks to the Principal and staff, in particular Mr Kieran Nolan, at Wooranna Park Primary School, where these classes have been hosted, for taking on this new activity.

#### Science Talent Search Presentation Evening

The Committee supported an entertaining local science communicator, Sean Elliott to present at this event, held on 27 November, making it a fun and lively occasion.

There has been a slow but steady start to our activities in 2014, following the terrific foundation work of Lynne Selwood. We have started to attract additional support and work out ways for us to communicate and coordinate activities. We look forward to making more connections and helping more teachers, students and their families in 2015.

#### FINANCE and AUDIT COMMITTEE

The Finance and Audit Committee met monthly to review finances, monitor the financial management plan and risk register and conduct a random audit of the monthly accounts from February to May 2014. To increase efficiency from June 2014 the functions of the Finance and Audit Committee were absorbed by the Executive Committee.

#### HONORARY TREASURER

It is my duty to report to the Royal Society's membership on the financial activities and financial performance of the Royal Society over the last year. The annual financial statements and the auditor's statement for the current year are included in the annual report.

The RSV is financially sound and has ample assets to cover its immediate and longer term requirements but needs to increase its funding sources to enable it to increase its activities. Seeking to increase those funding sources will be a major focus of the Executive Committee and the Council in the coming year.

The accounts show a deficit, which is entirely due to the inclusion of depreciation (a non-cash expense item), consistent with the Australian Accounting Standards.

We have been unsuccessful in diversifying our funding base and are still largely dependent on the income received from hiring our building. Rental makes up approximately 57% of our income in next year's budget, membership dues contribute a further 26% and franking credits 4%. On the expenditure side approximately 67% of our operational costs are salaries.

The Royal Society of Victoria Science Fund was formed from the bequest of Dr Phillip Law and other RSV funds as a perpetual fund. We retain the capital and only take a portion of the increase in value each year, therefore allowing it to grow so that in future years we will be financially sustainable. Our financial advisor, Equity Trustees, manages the fund governed by our investment mandate. The fund grew over the last year to \$1,219,873 of which 66% is attributed to the bequest of Dr Phillip Law. A transfer of \$50,000 was made from the fund to the operational budget consistent with Council's Financial Management plan so the current balance is \$1,169,873.

The healthy size of the fund means that the RSV is financially sound and will be so for many years to come but if we want to expand our activities we need further funding sources.

We continue to maintain a strong focus on fiscal prudence and our internal audit activities have included a verification of the asset register, monitoring of the risk register and a regular audit of expenditure to ensure that all accounts are correctly authorised and processed.

Lastly, I would like to thank my very helpful and active Finance and Audit Committee, and also acknowledge the support received from our Financial Administrative Officer and the Executive Officer.



#### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31st DECEMBER 2014

#### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act Victoria. The Council has determined that the Association is not a reporting entity.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

#### a. Income Tax

The Society is a tax exempt body.

#### b. Fixed Assets

An inventory of fixed assets was undertaken during the 2011 year and values established for assets physically in existence. The values reported reflect a realisable or replacement cost. Depreciation has been applied to these assets from 1st January 2011.

The building and improvements have been paid for by the Society over its lifetime. However, it should be noted that the building is constructed on land which is not owned by the Society but which is held by Trustees pursuant to statute. In view of this, neither the building nor the land is regarded by the Society as realisable assets.

Building and improvements are being amortised over forty years, in accordance with accounting practices. This period has been deemed to commence from 1st January 2010 on the basis that at this time, the restoration works had been completed. The amortisation to be written off to the income statement.

#### c. Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at reporting date.

#### d. Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### e. Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable. Interest revenue is recognised when received.

All revenue is stated net of the amount of goods and services tax (GST).

#### f. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST. Receivables and payables in the balance sheet are shown inclusive of GST.

#### g. **Investments**

Investments held are originally recognised at cost which includes transaction costs. The investments are now reported at market value.

#### **NOTE 17: DIVIDENDS**

This amount includes franking credits of \$11,282 and a transfer of \$50,000 from the Science Fund.

The Science Fund transfer was allocated to the Phillip Law Postdoctoral Prize, Research Medal and Science Talent Search sponsorship with the balance used to offset the operating deficit.

The withdrawal of \$50,000(2013 \$57,000) from the Sciences Fund is consistent with the financial management plan adopted by Council which states that between 40% and 60% of the increase in value of the fund may be withdrawn each year. Because of the loss of rental income Council approved the commencement of the withdrawals this year instead of next year as originally planned.

The increase in the fund during the 2014 year was \$83,710.62 before the transfer of the \$50,000. Actual dividends received and reinvested were \$46,248 during 2014.
